If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 6. Purchase Preference (Centre)

Purchase Preference linked with Local Content (PP-LC) Policy:

The bid clause regarding "Preference to Make In India products" stands modified in this bid and shall be governed by the PPLC Policy No. FP-20013/2/2017-FP-PNG dated 17.11.2020 issued by MoP&NG as amended up to date. Accordingly, bidders with Local Content less than or equal to 20% will be treated as "Non Local Supplier". The prescribed LC shall be applicable on the date of Bid opening. Sanctions on the bidders for false / wrong declaration or not fulfilling the Local Content requirement shall be as per the PPLC policy. Further following additional provisions are added in the certification and verification of local content provision of the Preference to Make in India clause:

- i. In case of foreign bidder, certificate from the statutory auditor or cost auditor of their own office or subsidiary in India giving the percentage of local content is also acceptable. 1. Tender Inviting Authority: This tender enquiry for procurement of chemicals is being invited by Director NIMR and Delivery should be at ICMR-NIMR. Successful bidder should supply products with maximum possi ble expiry period from the date of supply.

2. Eligibility: The bidder must be a Manufacturer or its authorized agent.

3. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture.

A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all t he proposals with the firms' participation to be disqualified.

4. ICMR-NIMR reserves the right to cancel the bid in part or full without assigning any reason and liability o n the buyer. On such cancellation the decision of the Director, ICMR-NIMR will be binding and final on the s ubject.

5. Packing: The Supplier shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the Contract, if any damage of goods d uring supply then supplier must change the good without extra charge.

6. Payment: 100% payment shall be made after receipt of complete goods in good condition, if any and no n-rectification of defects/ deficiencies not attended by the Supplier or otherwise. the firm is required to sub mit the following documents to ICMR-NIMR for payment.

8. Settlement of Disputes: (a) If any dispute or difference of any kind whatsoever shall arise between the p rocurement agency and the supplier in connection with or arising out of the Contract, the parties shall mak e every effort to resolve amicably such dispute or difference by mutual consultation.

(b) if, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual co nsultation, then either the Procurement agency or the Supplier may give notice to the other party of its int ention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given.

(c) Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the Goods under the contract. In the case of a dispute or difference arising betwe en the Purchaser and a domestic supplier relating to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the sole arbitrator appointed by Director ICMR-NIMR.

(d) Arbitration proceedings shall be conducted in accordance with the rules of procedure which are as follo ws.

(i) The venue of Arbitration shall be the place from where the contract is issued and the language of the ar bitration proceedings and that of all ICMR-NIMR and communications between the parties shall be English/ Hindi.

(ii) the decision of the majority of arbitration shall be final and binding upon parties.

(iii) Settlement of disputes through pre-institution mediation and settlement in accordance with the comme rcial courts, commercial division and commercial appellate division of High courts (Amendment) Act 2018, No. 28 of 2018 Chapter IIIA.

9. If the supplier fails to deliver any or all of the goods or fails to perform the services within the time fram e(s) incorporated in the contract, the purchaser shall, without prejudice to other rights and remedies availa ble to the purchaser under the contract, deduct from the contract price, as liquidity damages, calculated in dividually on each delayed performance of the contract including delivery, non-submission of documents,

etc. a sum equivalent to 0.5% per week of delay or part thereof until actual delivery or performance subjec t to a maximum of 10% of the contract price. Once the maximum is reached purchaser may consider termi nation of the contract. Since the Liquidated damages are in virtue of non-performance of services, it will at tract GST or nay other applicable taxes which in turn shall be deducted from the supplier.
