1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
8. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. It should be an electrophoresis system for nucleic acid quality control analysis.
2. It must not use any fragile capillaries for electrophoresis, instead use chips / tapes / plates.
3. It should analyze size, quantity and integrity of minimum of 1-16 DNA/RNA samples or NGS libraries in a single run.
4. It should be able to perform sizing, quantification and integrity of DNA/RNA samples or NGS libraries in a single step.

5. It should be able to analyze contamination of gDNA in cell free DNA with compatible kits.
6. It should be able to work on 1-2ul of sample and may provide sizing of range from 200 to 50,000 bp with sensitivity of 0.5pg/ μ L with compatible kits.
7. It should not be dependent on external/internal Nitrogen cylinder for running the Instrument.
8. It should have an integrated bar code scanner.
9. The Instrument software must automatically analyze data as gel image / electropherogram for each sample and software must offer feature for calculating the stability of RNA.
10. The Instrument must be provided with suitable/ compatible high-end Laptop and machine software with multiple license and free upgradation of software at no extra cost.
11. The Instrument must be offered with demonstration kit of available high sensitivity kit for DNA/RNA sample analysis.
12. The machine should have CE certification or equivalent with documentation

1. Tender Inviting Authority: This tender enquiry for procurement of chemicals is being invited by Director NII and Delivery should be at ICMR-NIMR. Successful bidder should supply products with maximum possible expiry period from the date of supply.

2. Eligibility: The bidder must be a Manufacturer or its authorized agent.

3. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture.

A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all the bids with the firms' participation to be disqualified.

4. ICMR-NIMR reserves the right to cancel the bid in part or full without assigning any reason and liability on the buyer. On such cancellation the decision of the Director, ICMR-NIMR will be binding and final on the subject.

5. Packing: The Supplier shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the Contract, if any damage of goods during transit then supplier must change the good without extra charge.

6. Payment: 100% payment shall be made after receipt of complete goods in good condition, if any and non-confirmation of defects/ deficiencies not attended by the Supplier or otherwise. The firm is required to submit the following documents to ICMR-NIMR for payment.

(a) Copy of Purchase order

(b) Copy of Extension order (if any)

(c) Invoice in original showing contract number, good description, quantity, unit price and total amount.

(d) Acknowledgement of Receipt of Goods issued by the consignee Institute/ Center:

8. Settlement of Disputes: (a) If any dispute or difference of any kind whatsoever shall arise between the procurement agency and the supplier in connection with or arising out of the Contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

(b) if, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consent, then either the Procurement agency or the Supplier may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of the matter may be commenced unless such notice is given.

(c) Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the Goods under the contract. In the case of a dispute or difference arising between the Purchaser and a domestic supplier relating to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the sole arbitrator appointed by Director ICMR-NIMR.

(d) Arbitration proceedings shall be conducted in accordance with the rules of procedure which are as follows:

(i) The venue of Arbitration shall be the place from where the contract is issued and the language of the arbitration proceedings and that of all ICMR-NIMR and communications between the parties shall be English/Hindi.

(ii) the decision of the majority of arbitration shall be final and binding upon parties.

(iii) Settlement of disputes through pre-institution mediation and settlement in accordance with the commercial courts, commercial division and commercial appellate division of High courts (Amendment) Act 2018, No. 25 of 2018 Chapter IIIA.

9. If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame incorporated in the contract, the purchaser shall, without prejudice to other rights and remedies available to the purchaser under the contract, deduct from the contract price, as liquidity damages, calculated individually on the basis of delayed performance of the contract including delivery, non-submission of documents,

etc. a sum equivalent to 0.5% per week of delay or part thereof until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maximum is reached purchaser may consider termination of the contract. Since the Liquidated damages are in virtue of non-performance of services, it will attract GST or other applicable taxes which in turn shall be deducted from the supplier.

10. GST will be applicable as per the latest Gol notification.
