**Phase 1: Immunization & Anti sera development (3-4 months)**

1. Immunization & Anti sera development in 3-6 mice and titer check in 3-4 months.
2. Weekly update on immunization process.
3. Antibody titre data determined via ELISA and/or western blot must be delivered.

**Phase 2: Hybridoma generation (2-3 months)**

4. Fusion of B-lymphocyte expressing anti-EXP-1 Ab with Myeloma cell and colony screening for positive clones validated by ELISA and/or western blot (Hybridoma generation).
5. Sub-cloning by limiting dilution, colony expansion, screening for positive clones
6. The MAbs to be selected based on high affinity towards EXP-1 target confirmed by ELISA and/or western blot.
7. Screening data after fusion, single cell cloning data, antibody sandwich pair i.e. the capture and detection antibody pair data must be delivered.
8. Atleast three capture and detection antibody pair of MAbs must be selected.

**Phase 3: Expansion & Purification of selected Mabs (2-3 months)**

9. 1 mg of each pair of MAbs must be delivered for initial ELISA screening.

**Phase 4: Sandwich Assay Development (1-1.5 months)**

10. Sandwich assay must be developed and screened against native antigen (EXP-1). Assay data must be shared.

4-5 mg of each capture and detection antibody pair MAbs must be further delivered.

8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
